# New Charitable Giving Rules Announced for 2020

In 2020, there are some new rules and regulations for charitable giving.

#### #1: Everyone can claim a deduction

In order to benefit from itemizing in 2020, your deductions must exceed the standard deduction of \$12,400 for a single filer or \$24,800 for a married couple filing a joint return (even more for those age 65 and older). You will be allowed to deduct up to \$300 in cash contributions to qualified charities even if you choose the standard deduction.

## #2: There is a higher ceiling on taxadvantaged giving

If you itemize deductions, previous tax rules prohibited claiming a deduction that exceeded 60% of your adjusted gross income (AGI) in a single year. In a unique 2020 provision, you can claim a deduction valued up to 100% of your AGI for charitable contributions. If you plan to make substantial gifts, this may be the most tax-friendly year to do it.
